

# CITY OF ANGUS

## REGULAR MEETING

### December 10, 2024

Mayor Julie Humphries called the meeting to order at 6:59 p.m.

Present for the meeting at roll call were Julie Humphries, Ken Cook, Becky Henderson, Eben Stover, Jerry Newsom and Dylan Tidwell. Dylan Tidwell was called out to a fire call when the meeting began.

Invocation was led by Kim Newsom.

Mayor Julie Humphries stated that she would entertain a motion to approve the minutes of the November 12th regular meeting. Jerry Newsom made a motion to approve the minutes. Motion was seconded by Eben Stover. Motion carried by unanimous vote.

#### **Angus VFD Report**

Kim Newsom reported that the Angus VFD received an update on the grant truck that will go into production in February 2025 and move to the assembly line in another location second week in June 2025, then will be able to receive regular updates on progress and are on schedule to receive the fire engine by the second week of August 2025.

VFD has until the end of 2024 to apply for the VFIS safety grant for the rehab trailer for the firefighters, which covers items such as an awning, chairs and cooling system. Getting quotes for price on an awning, portable water cooler and chairs to purchase. They have received this grant twice before which paid for the extractor and dryer they have now.

Angus VFD has received 194 calls through the end of November 2024, which exceeds the record for number of calls received. They have received more calls for Richland than normal since Richland VFD is not responding well to the calls.

#### **Sewer Report**

Kacy Perry was present and said everything is running smoothly. Two of the airlines in the plant rotted off, and have now been repaired. Bowman, environmental monitoring, thinks the Birdwell lift station issue could be a float needing replaced and coming to take a look at the blinking red light. The light only blinks at night and not during the day.

#### **Police Report**

Council reviewed the report.


### **Motion to Adjourn**
