Angus VFD Report

Kim Newsom reported that the Angus VFD will be holding a Fundraiser on November 9, 2024 from 5 p.m. until 7 p.m. There will be a to-go dinner with choices of chili, beans, crackers, cornbread and Fritos. You can also buy a ticket for a chance to win a gun safe with a rifle inside. Tickets will be a deck of playing cards specially printed for the Angus VFD. The purchaser will pay \$100.00 and get to pick a card. They will receive ½ of the card they choose. Once all cards have been sold, the drawing will be held and the person with the other half of the playing card drawn will bring their half of the playing card to the VFD to collect the prize.

The council will review the new contract between the City of Angus VFD and Navarro County. The only change from last year's contract is that the VFD will now be paid \$300.00 per truck instead of \$200.00 per truck.

The VFD is expecting a check this month from SureFire Insurance for approximately \$1,600.00.

The new fire engine is being built and the VFD will soon be able to go online and see the progress on the assembly line. The truck is expected to be delivered by June 2025.

Kim stated that NavCo Chronicle published an article naming Jerry Newsom as Hometown Hero for his 50 years service on the Angus VFD and the community.

As of October 8, 2024 the Angus VFD has responded to 160 calls for service.
