# CITY OF ANGUS REGULAR MEETING November 12, 2024

Mayor Pro-Tem Ken Cook called the meeting to order at 6:56 p.m.

Present for the meeting at roll call were Ken Cook, Becky Henderson, Eben Stover, Dylan Tidwell and Jerry Newson. Julie Humphries was absent.

## **Angus VFD Report**

Kim Newsom reported that the Angus VFD held the chili fundraiser Saturday November 9<sup>th</sup>, and lost money, but they are looking into different fundraising ideas for the future. The VFD sold all of the gun safe raffle cards for a total of \$4,800.00 raised and the drawing for the winner will be held on November 13, 2024.

VFD has until the end of 2024 to apply for the VFIS safety grant for the rehab trailer for the firefighters, which covers items such as an awning, chairs and cooling system.

Angus VFD calls were slow for the month of October compared to the year.

## **Sewer Report**

Kacy Perry was present and said it's been quiet, the lift station on Birdwell road needs the blinking light to be reset, and calling the manufacturer for help with that.

### **Police Report**

Council reviewed the report.

Jerry Newson reported that he just finished decals for their new patrol car, and they have 3 total in service.

Persons wishing to address the council regarding Agenda Items were given 3 minutes to voice their opinion before the council addressed the Items.

Roy McCain stated that the VFD is doing an outstanding job. He is concerned about the emergency response trailer (rehab trailer) and not having a specific vehicle to pull the trailer, and when a volunteer using their personal vehicle to pull the trailer who is liable if there is a wreck while pulling the trailer. He is also concerned about changing the name of the service road affecting the 71 mailboxes/residents having to change their addresses and voter registration cards as well.

#### **Old Business**

• ITEM # 1 — Consider removing from the table Item # 3 from August's agenda to discuss and consider naming the section of Interstate 45 that is within the city limits of Angus. Take action if necessary.

Eben Stover made a motion to remove this item from the table. Jerry Newsom seconded the motion.

A discussion was held, Jerry Newsom's main concern is the monetary cost on the City of Angus for the signage cost at \$500.00 per sign and would have to pay the state to install the signs. The City of Angus would be responsible for moving the signage and replacing the signs when/if they got hit and knocked down.

According to TxDot the easiest route is adding 1 or 2 numbers without changing the signs. The affected residents along the interstate would still have to change their addresses.

Becky Henderson stated that she doesn't think changing the name of the service road needs to be done right away.

A motion was made by Eben Stover to postpone this item for one year until November 2025. Motion was seconded by Becky Henderson. Motion was carried by a vote of 4 for and Dylan Tidwell abstaining due to conflict of interest.
