# CITY OF ANGUS REGULAR MEETING July 8, 2025

Mayor Julie Humphries called the meeting to order at 6:59 p.m.

Present for the meeting at roll call were Julie Humphries, Eben Stover, Ken Cook, Dylan Tidwell, and Jerry Newsom. Becky Henderson was absent.

Invocation was led by Kim Newsom.

## Angus VFD Report

Kim Newsom reported that the VFD has received one of our new fire trucks, a 2025 Ford F350 CC 4-door truck, and the other truck is in Haltom City at Daco and they are holding the truck until the grant money comes in. The second truck lacks storage and phone system. The VFD has received donations from Atmos Energy (\$1000) and Navarro County Electric Coop grant (\$875) and that money will be used to put equipment on both new trucks, including side steps for the F350, seat covers and floor mats.

Texas A&M will be hosting a fire safety school coming up to show new apparatus and new fire equipment, and both of our new trucks will be on display and we are really excited about that.

We have received lots of calls for June 2025, and have answered 120 calls. The call volume is way higher than this time last year. We talked to Eric Meyers, Navarro County Emergency Management coordinator, and will be doing high water rescue training soon with him or Darrell Cobb, so that we can be more prepared. We have gone out 3 times this year for water rescue calls. Darrell Cobb is currently in Hill County assisting with the search and rescue teams from the devastating July 4 flooding on the Guadalupe River.

We still have tickets to sale for our gun safe fundraiser, which has been posted and shared on Facebook.

### **Sewer Report**

Kacy Perry reported that it has been quiet. He talked to Bowman and asked him to come out and check the lift station with the blinking light, and thinks it must be something in the float system causing the light to constantly blink red.

# **Police Report**

Council reviewed the report. Jerry Newsom stated that they have hired a couple of new officers and that he had just finished decals on one of the police vehicles yesterday afternoon.

• ITEM # 1 – Discuss and consider for approval building application made by Jimmi Jackson for a 20 x 40-foot metal carport at 263 Tilton Rd. Take action if necessary.

• ITEM # 2 – Discuss and consider for approval mobile home application made by Ruben Sandoval for a 16 x 76 single wide mobile home at 122 Tilton Rd, on 0.483 of an acre. Take action if necessary.
