

CITY OF ANGUS REGULAR MEETING March 11, 2025

Mayor Julie Humphries called the meeting to order at 7:01 p.m.

Present for the meeting at roll call were Julie Humphries, Becky Henderson, Jerry Newsom, Ken Cook, Eben Stover and Dylan Tidwell.

Invocation was led by Kim Newsom.

Angus VFD Report

Kim Newsom reported that they received an update on the truck and it will not go into production until August, which is when the truck was supposed to be delivered to Angus. We have since found out that the production company Dayco has filed for Chapter 11 Bankruptcy in April of 2024, and that is having a impact on materials needed for production.

After speaking with the grant writers to find out what options they have, and have been told that we can terminate the contract with no penalty on us, and currently have a lawyer drawing up our termination letter for the contract.

Kim stated that they are now looking at getting two trucks, a custom cab would take 2-3 years to build a 2100-gallon tender, which is 400 gallons less than what we have. We could get a second commercial truck which is an ultra-high pressure brush truck, which can be used for medical calls, fire calls and to pull the rehab trailer. The grant writers are trying to do what they can to get us both trucks in place of the big engine we are now cancelling. The white truck will be retired and hoping to get one of both trucks by the end of the year.

Sewer Report

Kacy Perry reported that it has been quiet. He also reported that he spoke with the owner of Stuckeys and informed him that the issue hes been having is on him to fix, and not the City of

Angus. He also sent him the survey map showing that Angus is only responsible for 6 inches past the man hole, and his issue is beyond that.
