### **Angus VFD Report**

Jerry Newsom reported that they received a check from Surefire for almost \$8,000 this month for insurance claims, with the majority of that from a big bus fire that burnt near the rest area. They have been very busy with calls for the first quarter of this year, and already have received more calls than this time last year.

After speaking with the grant writers, they asked if Daco has contacted us regarding their filing for Chapter 11 Bankruptcy in April of 2024, which they have not contacted us. The last update we got from them on the cabin chassis, was that it would be delivered to us on December 1<sup>st</sup>, 2025, which is a breach of contract since the original delivery date was August 2025.

Jerry also stated that they received approval from TDA to purchase a tender truck and a 150gal brush truck with the grant money and it fits in our budget to purchase both trucks. Angus Volunteer Fire department will be the only VFD in Navarro County with a brush truck once we receive it.
