ORDINANCE NO. 102

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS DESIGNATING A TEMPORARY SPEED LIMIT OF 55 MPH DURING THE RECONSTRUCTION OF INTERSTATE HIGHWAY 45; PROVIDING A GENERAL PENALTY FOR VIOLATIONS, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Angus was requested by the Texas Department of Transportation to reduce the speed limits of Interstate Highway 45 to 55 miles per hour (mph) during the construction and widening of the highway;

WHEREAS, on December 18, 1995 the Angus City Council adopted an ordinance to reduce the speed along Interstate Highway 45 during this construction period;

WHEREAS, the City Council has now been requested by the Texas Department of Transportation to reestablish the speed limits of 70 mph along Interstate Highway 45 since construction work has been completed.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

ARTICLE 1. Ordinance No. 91 Repealed

Ordinance No. 91 adopted by the City Council on December 18, 1995 is hereby repealed.

ARTICLE 2. 70 MPH Speed Limit Established for Interstate Highway 45

The maximum speed limits along Interstate Highway 45 shall be 70 miles per hour or as otherwise posted by the Texas Department of Transportation.

ARTICLE 3. General Penalty for Violation

If any person operates or drives any motor vehicle or other vehicle greater than the speed limits established, it shall be prima facie evidence that such person violated this ordinance and that he or she shall be guilty of a misdemeanor which said offense shall be punishable by fine in any sum not to exceed two hundred dollars (\$200.00) per occurrence.

ARTICLE 4. Severability Clause

That should any article or section of this ordinance be decreed to be void, the invalidity of such article or section shall not affect the validity of the remaining portions of this ordinance and that each article and section or portion thereof not decreed to be invalid shall remain valid and enforceable.

ARTICLE 5. Effective Date

This ordinance shall take effect immediately upon its passage and publication as the law requires.

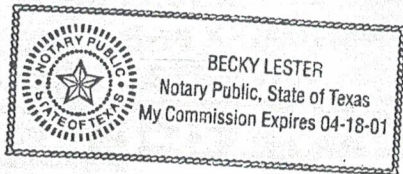

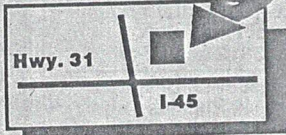
