### Ordinance No. 105

THOMAS AN ORDINANCE OF THE CITY OF ANGUS, TEXAS AMENDING THE ZONING BY BURIE HUMPRIES CONSISTING OF N A COURSE ACRE T'APPROXIMATELY FOUR ACRES IN A 29.887 ACRE TRACT SITUATED IN THE TERRITORIAN JOHN WHITE SURVEY, ABSTRACT 818, NAVARRO COUNTY, TEXAS, FROM RESIDENTIAL TO COMMERCIAL DISTRICT; REPEALING TO CODE PROVISIONS, PROVIDING FOR AN CHAIN EFFECTIVE SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE.

## THE CUBE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

Section 1: That the zoning for certain property owned by Julie Humphries as further described sudential 1 Dans hereinafter is hereby changed from Residential-1 District to Commercial District. described as follo description for such property is more fully described as follows:

20.887 acre tract situated in the John White Survey, and the language of the Abstract 818, Navarro County, Texas and being described in a deed from Richard J. Butier, Station Venture, ET to Kenneth Folmar Trustee, Pecan Valley Joint Venture, recorded in Volme 1061, Page secreted described in 729, and in part of a called 32.527 acre tract described in a deed from Carlton J. Ware to Venture, recorded in Volume 1062, Page 272, deed records, Navarro County, Texas.

Section 2: That it is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconsitutional by the valid judgement or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the city council without the incorporation and physics, clause, in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

Oction Section 3: All provisions of the Angus Code of Ordinances, any other ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

> Section 4: This ordinance shall take effect immediately from and after its passage and the publication of its caption, as the law in such cases provides.
