# ORDINANCE NO. 119

AN ORDINANCE ADOPTING AND ENACTING A NEW CODE FOR THE CITY OF ANGUS, TEXAS; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN; PROVIDING A PENALTY FOR THE VIOLATION THEREOF; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE; AND PROVIDING WHEN SUCH CODE AND THIS ORDINANCE SHALL BECOME EFFECTIVE.

# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

Municipal Code Corporation, consisting of chapters 1 through 62, each inclusive, is adopted.

All ordinances of a general and permanent nature enacted on or before April 8, 2003, and not included in the Code or recognized and continued in force by reference therein, are repealed.

Section 3. The repeal provided for in section 2 hereof shall not be construed to revive any ordinance or part thereof that has been repealed by a subsequent ordinance that is repealed by this ordinance.

Section 4. Whenever in this Code or in any ordinance, resolution, rule, or police regulation of the city an act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or the doing of any act is required or the failure to do any act is declared to be unlawful, where no specific penalty is provided, the violation of any provision of this Code or any ordinance, resolution, rule, or police regulation shall be punished by a fine not exceeding \$500.00; provided, however, that the violation of any provision of this Code or any ordinance, resolution, rule, or police regulation that governs fire safety, zoning, or public health and sanitation, including dumping of refuse, shall be punished by a fine not exceeding \$2,000.00. Where the offense is one for which a penalty is fixed by state law, the penalty for such offense shall be the same as fixed by state law. The penalty provided by this section, unless another penalty is expressly provided, shall

apply to the amendment of any Code section, whether or not such penalty is reenacted in the overded in the amendatory ordinance. Except as otherwise provided in this Code, each day an offense continues to the penalty behalf constitute a separate offense. In addition to the penalty prescribed above, the city may 0ursue other remedies such as abatement of nuisances, injunctive relief, administrative adjudications,

Section 6. Ordinances adopted after April 8, 2003, that amend or refer to ordinances that have been codified in the Code shall be construed as if they amend or refer to like provisions of the Code.
