ORDINANCE NO. 123

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS AMENDING THE CITY'S CODE OF ORDINANCES IN ORDER TO LEVY AND COLLECT A FEE NOT TO EXCEED ONE-HALF THE STATE FEE FOR EACH ALCOHOLIC BEVERAGE PERMIT ISSUED OR RENEWED FOR PREMISES LOCATED WITHIN THE CITY OF ANGUS AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Angus may levy and collect a fee for each alcoholic beverage permit issued or renewed for premises located within the City of Angus,

WHEREAS, the City Council of Angus hereby desires to levy and collect a fee equal to one-half of the state permit fee for each alcoholic beverage permit issued or renewed for premises located within the within the city limits; now therefore:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

ARTICLE 1. LOCAL FEE FOR ALCOHOLIC BEVERAGE FEE AUTHORIZED

(a) From the effective date of this ordinance, the City Council of Angus hereby desires to levy and collect a fee equal to one-half of the state fee for each permit issued or renewed for premises located within the within the city limits of the City of Angus, Texas.

(b) The Mayor and/or City Secretary is hereby directed to submit all required documents and information to the Texas Alcoholic Beverage Commission in order to ensure that the City receives and collects such fee.

ARTICLE 2. SEVERABILITY CLAUSE

That should any article or section of this ordinance be decreed to be void by a court-of-law or in conflict with the Texas Alcoholic Beverage Code, the invalidity of such article or section shall not affect the validity of the remaining portions of this ordinance and that each article and section or portion thereof not decreed or found to be invalid shall remain valid and enforceable.

ARTICLE 3. CONFLICTING ORDINANCES OR CODE PROVISIONS REPEALED


That all ordinances or any part of the City's Code of Ordinances that are in conflict with this ordinance are hereby repealed.

ARTICLE 4. EFFECTIVE DATE

This ordinance shall take effect immediately upon its passage and publication as the law requires.

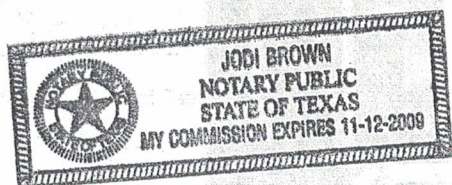
