AN ORDINANCE OF THE CITY OF ANGUS, TEXAS AMENDING THE CODE OF ORDINANCES, CITY OF ANGUS, ARTICLE III CHAPTER 58-84 "UTILITIES" SEWER SERVICE FEE BILLING PROCEDURES AND PROVIDING A PENALTY FOR VIOLATIONS.

WHEREAS, the City of Angus has determined that the sewer service billing procedures as fixed in Article III, sec. 58-84 in the Code of Ordinances, City of Angus, should be amended at this time to include procedures for collecting late fees and termination of water service on overdue accounts.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Angus, Texas that the sewer service fee billing procedures for the City of Angus, Texas be amended and set out so that henceforth Article III, Section 58-84 shall read as follows:

SEC. 58-84. Sewer service fee billing procedures.

onthly and an Monthly sewer service fees shall be invoiced monthly and are due and payable upon receipt of bill.

Bills not paid by the due date will be assessed a \$10.00 late fee.

Customers will be given 10 days from the due date to pay the bill. On the first business day after the 10<sup>th</sup> day a written notice will be taken to the Angus Water Supply Corporation to cut off the customer's water service. A cut off fee will be assessed at a rate billed to the city by the Angus Water Supply Corporation and water service will not be restored until the customer pays the entire amount due, including the original amount due plus the late fee and any fees charged by Angus Water Supply Corporation to cut off and restore water service.
