Ordinance No. 152

AN ORDINANCE OF THE CITY OF ANGUS, TEXAS AMENDING CHAPTER 58, ARTICLE III UTILITIES, SECTION 58-83 MONTHLY SEWER SERVICE FEES.

WHEREAS, the City of Angus has determined that the sewer rates as fixed in Article III, Sec. 58-83 is at this time inadequate to cover all operation costs for sewage collection and treatment.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Angus, Texas that the sewer rates for the City of Angus be amended as hereinafter set out so that henceforth Section 58-83 shall read as follows:

SEC. 58-83. Monthly sewer service fees.

The following schedule of monthly fees for sewer services furnished by the City of Angus is established:

Residential

\$30.00 per connection per month beginning Oct. 1, 2017

Small Volume Commercial

\$60.00 per connection per month base fee plus \$1.00 per 1000 gallons of water used each month, after the first 2000 gallons beginning Oct. 1, 2017. Sewer rates for the RV Park will remain at a flat rate of \$105.00 per month (\$5.00 per site for 21 sites).

Large Volume Commercial & Industrial Usage on a case-by-case basis beginning Oct. 1, 2017

Any use other than residential shall be considered commercial. More than one residential unit per connection shall be classified under commercial rates. Mixed residential and commercial use shall be classified as commercial.


