

Ordinance No. 159

AN ORDINANCE OF THE CITY OF ANGUS, TEXAS AMENDING THE CODE OF ORDINANCES, CITY OF ANGUS, TEXAS, CHAPTER 6, ANIMALS, TO ADD SECTION 6-13, MULTIPLE OWNERSHIP AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Angus, Texas has determined that the City of Angus, Code of Ordinances Chapter 6, Animals, be amended to add Section 6-13, Multiple Ownership.

THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS that the City of Angus, Code of Ordinances to add Section 6-13, Multiple Ownership.

Sec. 6-13 – Multiple Ownership

It shall be unlawful for any person to keep or any household to have more than four (4) adult dogs and four (4) adult cats at any one residential location which is situated in an area of one-half (1/2) acres or less within the City of Angus, Texas. A litter under three (3) months shall not be counted for the purpose of this section.

Effective Date

This ordinance shall take effect on November 13, 2018.

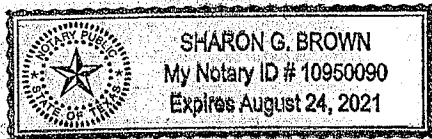
