

ORDINANCE 170

AN ORDINANCE AMENDING THE CITY OF ANGUS CODE OF ORDINANCES, CHAPTER 2 ADMINISTRATION; ARTICLE V FINANCE; DIVISION 2 BUDGET; SECTION 2-272 BUDGET OFFICER; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is occasionally necessary to make emergency repairs to the sewer system, sewer lines, building/grounds, and streets within the City of Angus, and

WHEREAS, the City of Angus has determined that the Code of Ordinances, Chapter 2, Article V, Division 2, Section 2-272 be amended

BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF ANGUS, TEXAS:

Section 1

That Chapter 2, Article V, Division 2, Section 2-272 be amended to add the following:

The Budget Officer shall be authorized to spend an amount up to, but not exceeding \$20,000.00 as he/she deems necessary without prior approval of the City Council.

Section 2

This ordinance shall be cumulative of all provisions of ordinances and the City of Angus, Code of Ordinances, as amended, except where provisions of this ordinance are in direct conflict with the provisions of such ordinances and Code, in which event such conflicting provisions of such ordinances and Code are hereby repealed.


Section 3

It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable, and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared void, ineffective or unconstitutional by the valid judgment or final decree of a court of competent jurisdiction, such ineffectiveness or unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation herein of any such void, ineffective or unconstitutional phrase, clause, sentence, paragraph or section.

Section 4

This ordinance shall be in full force and effect from and after its passage, and it is ordained.

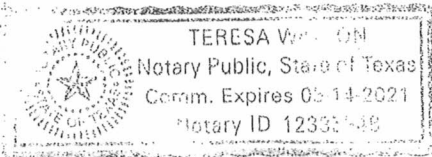

Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by the date. The letter must include the person's name, address, email address and fax number if applicable.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for a final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.

A landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the requested area, may file a written request with the Commission to be excluded from the requested area ("opt out") within (30) days from the date that notice was provided by the Utility. All opt out requests must include a large-scale map, a metes and bounds description of the landowner's tract of land, landowner's name, address, email address and fax number, if applicable.
