AN ORDINANCE DEANNEXING CERTAIN PROPERTY FROM THE CITY OF ANGUS AND APPROVING AN EXTRATERRITORIAL JURISDICTION AGREEMENT BETWEEN THE CITY OF MUSTANG AND THE CITY OF ANGUS.

WHEREAS, the City of Mustang and the City of Angus has agreed to effect an extraterritorial jurisdiction agreement as outlined herein, and whereas the City of Angus has agreed to deannex certain territory in consideration thereof;

NOW THEREFORE BE IT ORDAINED:

I

That the City of Angus hereby releases its extraterritorial jurisdiction to the City of Mustang with respect to the territory indicated on Exhibit A attached hereto.

II

That the City of Mustang hereby releases its extraterritorial jurisdiction to the City of Angus with respect to the territory indicated on Exhibit A attached hereto.

III

That the City of Angus hereby deannexes that tract of land 300' X 300' lying on the east side of Interstate Highway 45 adjacent to the City of Mustang shown on Exhibit A attached hereto.

IV

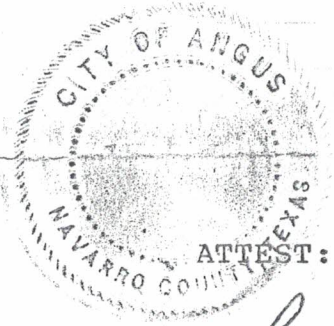

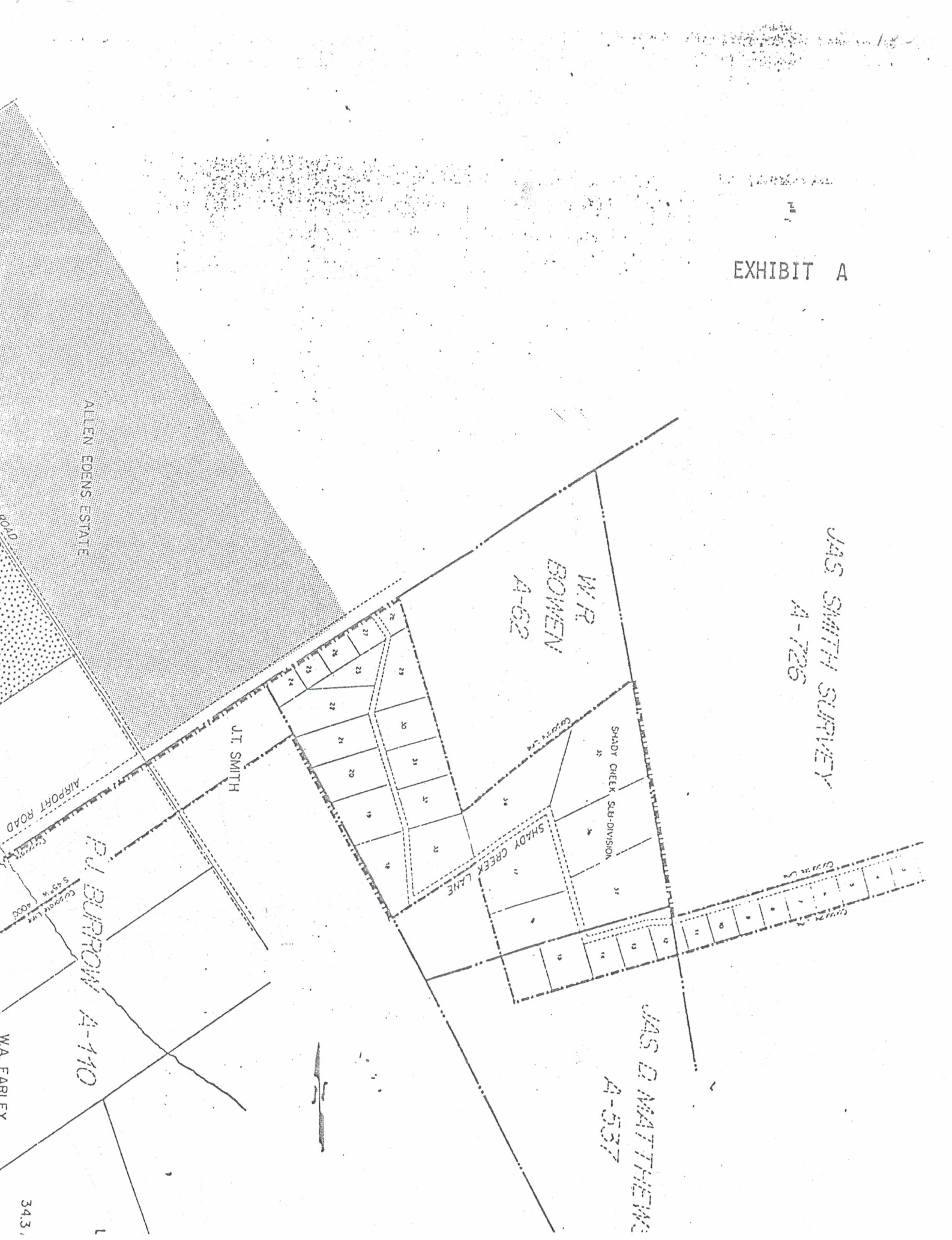

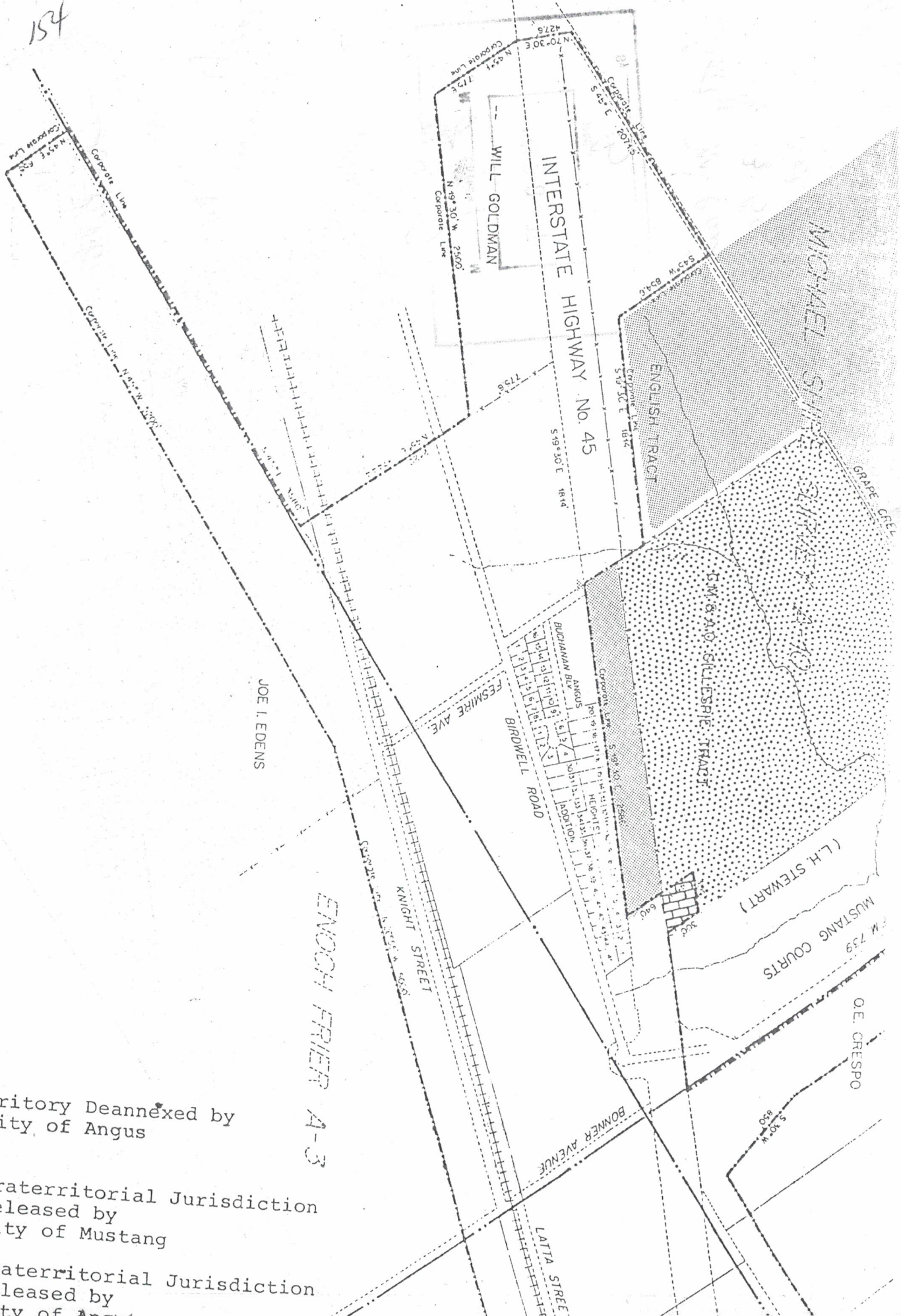
