ORDINANCE NO. 56

OF OAN ORDINANCE AMENDING THE CODE OF ORDINANCES

TO AMEND OF THE CITY OF ANGUS, TEXAS TO AMEND SECTION

9.A(1), CHAPTER 8 PROVIDING FOR RESTRICTIONS

ON LOT SIZES; TO ESTABLISH ONE-HALF (½) ACRE

AS THE MINIMUM LOT SIZE IN NEW SUBDIVISIONS;

PROVIDING FOR THE REPEAL OF ORDINANCES IN

PROVIDING FOR A PENALTY NOT TO EXCEED FIVE

HUNDRED DOLLARS (\$500.00); AND PROVIDING FOR

AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

SECTION I

That Chapter 8 of the Code of Ordinances of the City of Angus, Texas is hereby amended to amend section 9.A(1) which shall read as follows:

SECTION 9: STANDARDS AND SPECIFICATIONS

A. GENERAL

(1) Each lot shall front upon a public street and shall be a minimum of one-half $(\frac{1}{2})$ acre in size if served by a public water system and shall be a minimum of one (1) acre in size if not served by a public water system.

SECTION II

That all ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

SECTION III

That it is hereby declared to be the intention of the city council that the sections, paragraphs, sentences, clauses, and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph, or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any

court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of this ordinance, since the same would have been enacted by the city council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph, or section.

SECTION IV

That whenever in this ordinance an act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or wherever in such ordinance, the doing of an act is required or the failure to do any act is declared to be unlawful, the violation of dany such provision shall be punished by a fine of not exceeding five hundred dollars (\$500.00); provided, however, that no penalty shall be greater or less than the penalty provided for the same or similar offense under the laws of the state. Each day any violation of this ordinance shall continue shall constitute a separate offense.

SECTION V

That this ordinance shall take effect immediately from and after its passage and the publication of the caption, as the law in such cases provides.




