## CITY OF ANGUS, TEXAS ORDINANCE NO. 70

AN ORDINANCE OF THE CITY OF ANGUS, TEXAS, APPROVING AND ADOPTING A BUDGET FOR THE CITY FOR THE FISCAL YEAR APRIL 1, 1990 THROUGH MARCH 31, 1991 AND PROVIDING THAT EXPENDITURES FOR SAID FISCAL YEAR SHALL BE MADE IN ACCORDANCE WITH SAID BUDGET.

WHEREAS, the Mayor of the City of Angus, Texas, has heretofore filed with the City Secretary a proposed budget for the city covering the fiscal year April 1, 1990 through March 31, 1991; and

WHEREAS, the governing body of the city has this date concluded its public hearing on said budget;

te instal year of SECTION 3: That expenditures during the fiscal year shall be made in accordance with the budget approved by this ordinance unless otherwise authorized by the City Council.

SECTION 4: That the necessity for making and approving a budget for the fiscal year as required by the laws of the State of Texas, creates an urgency and an emergency and requires that this ordinance shall take effect from and after its passage, as the law in such cases provides.
