Ordinance No. 97

AN ORDINANCE OF THE CITY OF ANGUS, TEXAS AMENDING THE ZONING OF CERTAIN PROPERTY OWNED BY J. B. AND ALICE STEELE CONSISTING OF LOT 24 OF THE SOUTHERN PLANTATION ESTATES ACCORDING TO AN UNRECORDED SUBDIVISION PLAT IN THE JOHN MCNEAL SURVEY, A-8, NAVARRO COUNTY, TEXAS, FROM RESIDENTIAL 2 DISTRICT TO COMMERCIAL DISTRICT; REPEALING CONFLICTING ORDINANCES AND CODE PROVISIONS; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

Section 1: That the zoning for certain property owned by J. B. and Alice Steele as further described hereinafter is hereby changed from Residential-2 District to Commercial District. The description for such property is more fully described as follows:

Lot 24 of the Southern Plantation Estates according to an unrecorded subdivision plat in the John McNeal Survey, A-8, Navarro County, Texas and more specifically described in "Exhibit A" attached hereto and incorporated herein by reference for all purposes.

Section 2: That it is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgement or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the city council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

Section 3: All provisions of the Angus Code of Ordinances, any other ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

Section 4: This ordinance shall take effect immediately from and after its passage and the publication of its caption, as the law in such cases provides.
